IPARD – solid performance since 2011- based on EU rural development model

Investment projects in **modernisation** of farms, food processing and diversification and gradual adjustment to **EU hygiene, animal welfare and environmental standards** – benefits for citizens of Turkey

IPARD I – since 2011 till 2013 (+3)

- 10,650 projects implemented
- 50,000 jobs created.

IPARD II : since 2017

- 22,500 project proposals received
- 6,600 projects contracted (470 million EUR of from the EU)
- 3,200 projects completed (145 million EUR from the EU)
